- All riders **must have a properly fitting helmet, boots with a heel** and wear long pants. We do realize riding is an expensive sport and children grow quickly, so we do have a small exchange program for apparel that kids have grown out of and do have a few pairs of boots at the barn that may be borrowed. *(Riders will NOT be allowed to ride in shorts or sneakers, it is not safe)*
- Riders should bring plenty of water or other drink and a snack. (Refrigerator and microwave are available for camper use.)
- You may consider bringing a change of clothes for water games on very hot days.
